Who is eligible:

All active ContainerPort Group (CPG®) and Pacific Cascade drivers as of the start of National Truck Driver Appreciation Week (TDAW), beginning on **September 15th, 2024**, and any new hires that contract with CPG or Pacific Cascade during TDAW.
